## NOTIFICATION REQUIREMENTS

Breeding season for some stallions can be busy and we ship on a first-come basis in the event that a stallion is unable to provide the required number of doses on a given day.

1. MARE OWNER hereby understands and agrees that in order to allow sufficient time for semen collection and processing, notification of the need for a shipment will be provided to Equine-Reproduction.com LLC (hereinafter referred to as SHIPPER) no later than 10:00 am US Central Time on the day that the collection for shipment is required. While every effort will be made to accommodate orders placed after that time, if transport to the courier depot is required, there will be a surcharge of \$150 made in addition to all other collection and shipping charges, and furthermore in some cases, a shipment may not be possible.

2. SHIPPER will make every effort to accommodate mare owner in performing the shipment of semen, but is not responsible in the event that semen collection cannot be achieved, shipment does not arrive as anticipated, if it is lost, stolen or damaged in transit, or if a pregnancy of the mare is not forthcoming.

3. SHIPPER is solely responsible for management of the stallion and does NOT guarantee the quality or fertility of the semen. Any contracts and statements made by the stallion owner to mare owner are not the responsibility of the SHIPPER and are by and between stallion owner and mare owner. Information relating to the quality of the semen at the time of collection will be provided and will accompany the shipment at the time of shipping;

4. MARE OWNER recognizes that dealing with stallions, as with any horse, can have unpredictable outcomes, and therefore understands that while every effort will be made to achieve a collection, in some circumstances, a collection may not be possible;

5. MARE OWNER and their veterinarian are responsible for determining suitable timing with regard to the mare for the ordering of the semen;

6. MARE OWNER is responsible for all contracts, fees, dues, etc., being paid, International permits (e.g. Canada) provided, and notification made to SHIPPER prior to shipment of semen taking place. Semen will not be shipped without stallion owner's prior approval and written authorization. Please be sure that the stallion owner's requirements have been met prior to requesting a shipment of semen. Note that International shipments to Canada require import/export permits and are subject to additional charges for USDA certification etc.;

7. MARE OWNER is responsible for all semen collection, processing, permitting and shipping expenses, and container deposits, etc. Please be sure that SHIPPER has a credit card number and fee approval with your signature on file, or a deposit in escrow, prior to requesting a shipment of semen. If paying by credit card, we will not ship semen without a signed approval for use of your credit card, nor without the charge having been successfully processed. Prior to shipping, a deposit of Three hundred Dollars US (\$300.00) is required. This deposit will be refunded upon return of the shipping container, cleaned and in good condition within the time frame detailed in (8) below. The semen collection, processing and shipping fees are non-refundable. SHIPPER is not responsible for delayed, lost, stolen, or damaged shipments;

8. MARE OWNER is responsible for the return of the shipping container cleaned and in good condition within four (4) days of receipt of same. In the event the shipping container is not returned within said four (4) days, MARE OWNER will be assessed a \$25.00 daily rental fee; if the container is returned un-cleaned with semen residue or other unclean matter within the container, there will be a \$25 cleaning charge levied even if the container is returned in a timely manner. To clean a container, all that is required is that inside components be rinsed with hot water and wiped clean and dry.

We at Equine-Reproduction.com LLC understand and appreciate that mares do not cooperate with the best laid best plans, however in order to facilitate and ensure that semen is shipped in a timely fashion, we ask that all attempts be made to complete the requests outlined above.
