Breeding Management Fee for Mares: \$450 for fresh or cooled semen and embryo transfer recipient mares; \$550 for all mares being bred with frozen. This is due when the mare arrives at the facility.

Board is in addition to the breeding management fee. Breeding management fee is for one cycle and does not include additional veterinary charges.

Board for mares is at a rate of \$20.00/day dry and \$25.00/day wet (with a foal at foot). For mares bred by us and confirmed 24 days or more in foal, board will increase to \$30.00/day dry and \$35.00/day wet.

Trailer-in-&-out services: Payment due at time of service. Additional veterinarian expenses may be billed separately & payable as invoiced.

TERMS AND CONDITIONS:

Initial _____ 1. All board, veterinary, medical, farrier and other related expenses on the above named animal will be paid by the horse owner and are payable monthly. A 1.5% monthly service charge (18% annual) will be levied on accounts 30 days past due. All unpaid balances must be paid prior to the departure of the animal from Equine-Reproduction.com, LLC. Board rates are subject to change only after written

Initial ______4. Equine-Reproduction.com, LLC reserves the right to refuse or reject any horse.

Initial _____ 5. Foals older than 9 days of age not suitably halter broken will be subject to a \$150 additional charge.

Initial _____ 6. If animal is unruly, Equine-Reproduction.com, LLC reserves the right to charge owner for any special training or management required to maintain animal properly and safely and owner agrees to pay said fee.

Initial _____ 7. Owner hereby authorizes Equine-Reproduction.com, LLC, at owner's expense, to transport horse or consent to such transportation as is necessary by any third party selected by Equine-Reproduction.com, LLC while such animal is under the care, custody and control of Equine-Reproduction.com, LLC.

Initial ______ 8. Owner will notify Equine-Reproduction.com, LLC at least 24 hours prior to delivering and/or picking up animal. The facility is open for delivery and pick up 9-5 pm Mon-Fri and 10-12 am Sat and Sun. Arrangements must be made at least 48 hours ahead of time for delivery or pick up outside these hours and may not be available.

Initial ______ 9. Mares removed from the property prior to pregnancy check may be subject to a charge for that service if returned at a later date. These are performed by the staff veterinarian only by appointment, on Wednesdays and Fridays 9-10 am and 4-5 pm (subject to emergency calls), with bookings to be made by Wednesday for Friday, and Friday for the next Wednesday, and a charge applies. Alternatively, the mare may be returned and left for an entire day, in which case no charge will apply.

Initial ______10. It is mutually agreed that Equine-Reproduction.com, LLC, Jos C. Mottershead, Kathy St.Martin, their staff or any personnel associated with the above shall not be liable for any sickness, disease, theft, death, accident and/or injury caused to or by the above named animal during the time the horse is in the care, custody of or under the control of Equine-Reproduction.com, LLC or for any claim or cause of action whatsoever arising out of or in any way connected with Equine-Reproduction.com, LLC's, management, care, custody, control, breeding, boarding or transporting the animal. This includes but is not limited to any personal injury or disability, commercial loss or damage, consequential or collateral damages, or any other expense or cost which owner of said animal may receive while owner or horse are in/under the control of Equine-Reproduction.com, LLC.

Equine-Reproduction.com, LLC will exercise judgment in care and supervision of owner's horse. Equine-Reproduction.com, LLC's veterinarian of choice will administer veterinary care as he/she sees necessary for the health and safety of the horse at the owner's expense. Owners agree that the staff may give any necessary inoculations or treatments under the general supervision of EquineReproduction.com, LLC's veterinarian and that the Equine-Reproduction.com, LLC, their staff, the veterinarian and/or veterinary staff will not be liable for these treatments or consequences therefrom.

Initial _____ 12. The owner fully understands that Equine-Reproduction.com, LLC, Jos C. Mottershead, Kathy St.Martin and/or their staff, do not carry any of the owner's horses that are in their possession on any form of equine insurance and will not be responsible for any violation of the terms or a lapse of any policy of insurance carried by the owner.

Initial _____ 13. This contract signed by the respective parties constitutes the entire agreement between the parties and same may not be modified except by mutual exchange of written instruments.

Initial _____ 14. In event of breach of this contract or any part thereof, owner agrees to pay any and all reasonable fines and necessary attorney fees or other expenses of any kind incurred or which may be incurred by or on behalf of Equine-Reproduction.com, LLC.

Initial ______15. The owner of the horse hereby grants a lien on the horse to Equine-Reproduction.com, LLC for all charges resulting from breeding, boarding, semen shipments, and/or rendering any other services to the animal. If any such charges shall be unpaid for a period of thirty days or more after they become due in accordance with the terms of this contract, Equine-Reproduction.com, LLC may upon ten day's written notice to the owner, specifying the amount due and informing them that the payment of the amount due if not received within ten days will entitle Equine-Reproduction.com, LLC to assume possession of the horse and sell the horse at public auction or private sale to satisfy the account. Balances over the amounts due, less any costs associated with the sale of the horse, shall be paid to owner. Balances left owing after such sale shall still be considered a debt due to Equine-Reproduction.com, LLC.

Initial _____ 16. Riding of owner's horses on the premises of Equine-Reproduction.com, LLC is prohibited without the express permission of Jos Mottershead or Kathy St. Martin. Owner assumes all risk of loss and 3rd party liability if permission to ride on Equine-Reproduction.com, LLC property is granted. Owner may contract with Equine-Reproduction.com, LLC for additional exercise, riding or turnout if appropriate staffing is available.
